ORDINANCE 12 - 157

An ordinance amending Section 1 and 2 of Ordinance 12 -147 and setting new deposits, taps and reconnect fees; as authorized by L.R.S. 47:299.1 et seq, and to provide for related matters.

SECTION 1. That the following uniform water rate schedule and rules and regulations be and the same are hereby adopted within the Town of Chatham, Louisiana to-wit:

WATER RATES

Flat Rate – 1000 gallons	\$12.50
All above 1000 gallons	\$0.0039 per gallon

SECTION 2. That the following uniform sewer rate schedule and rules and regulations be and the same are hereby adopted within the Town of Chatham, Louisiana to-wit:

SEWER RATES

Residential:

Flat Rate – 1000 gallons	\$10.00
All above 1000 gallons	\$0.0039 per gallon

Business:

Flat Rate – 1000 gallons	\$18.50
All above 1000 gallons	\$0.0039 per gallon

SECTION 3. That the following deposits are hereby adopted within the Town of Chatham, Louisiana to-wit:

SECTION 4. That the following tap fees are hereby adopted within the Town of Chatham, Louisiana to-wit:

Water Tap	\$250.00
Sewer Tap	\$250.00
Gas Tap	\$500.00

SECTION 5. That the following reconnect fee is hereby adopted within the Town of Chatham, Louisiana to-wit:

Reconnect fee: \$40.00

This ordinance shall become effective on July 1, 2017.
