ORDINANCE 2021 - 03

AN ORDINANCE SETTING THE SALARY FOR THE MUNICIPAL CLERK FOR THE TOWN OF CHATHAM, JACKSON PARISH, STATE OF LOUISIANA

BE IT ORDAINED, by the Board of Aldermen for the Town of Chatham, Jackson Parish, State of Louisiana, as follows:

SECTION I

Pursuant to LA RS §404.1, the current rate of pay for the Municipal Clerk for the Town of Chatham, Jackson Parish, State of Louisiana shall be adjusted to \$30,000.00 per year.

SECTION II

The Municipal Town Clerk shall receive a yearly cost of living raise that will be based on the Social Security Administration Cost-of-Living Adjustment (COLA).

SECTION II

The Board of Aldermen gives the Mayor the authority to increase the Municipal Clerk's salary from 1% - 5% based on performance review and budget.

SECTION III

The rate set forth in section I above shall take effect on May 14, 2021.

SECTION IV

That this ordinance shall supersede and take precedence over any previous enacted ordinance or legislation pertaining to rates of pay for the office of the Municipal Clerk as provided for in Sections I - III above.
